Mr. Williams asked about an outstanding issue with the ordinance change 25O-06-124. Mr. Hobbs said the ordinance passed at the September 08, 2025, city commission meeting. Ms. Anderson will forward a copy of the approved ordinance. Mr. Williams will send to plan actuary, and the State of Florida – Division of Retirement accordingly. Mrs. Ostrander will ensure the auditor is presented a copy as well.

Mr. Williams stated that he emailed Mr. Dulaney to prepare a list of members required to begin pension contributions once they completed 60 months in the DROP and remained employed up to 84 months. Mr. Hennessy would like to get something in writing from Mr. Dulaney so the police department can process a status change request form. Mr. Hennessy has spoken to Cici regarding the pension contributions and how the payments will be made. Cici stated that she will have to make a status change. Mr. Williams will address accordingly. Ms. Anderson asked when a member has to notify the plan if they are extending their DROP. Mr. Hennessy stated that it is automatically extended, however when you start year 6 you have to pay 1 ½ %. Mrs. Ostrander will send Mrs. Klausner – Parrish a copy of our current DROP forms to review and update as needed.
